General Instructions:

- Priority will be given to Animal Sciences candidates; candidates with qualifications in Fisheries Sciences will be considered only if Veterinary / Animal Sciences candidates are not available. The decision of the Selection Committee to arrive at a conclusion to this effect and the criteria to be adopted thereon shall be binding on both the KVK's Management and all the candidates. Aspiring candidates should note this norm before submitting the application form.**
- The prescribed Application Form may be downloaded from the website www.jsskvk.in.
- Candidates whose applications are screened as per norms will be called for interview.
- No TA/DA will be admissible to attend the interview.
- The last date for receipt of application will be **30 days** from the date of publication of advertisement in Employment News. If the last date happens to be a Sunday or closed holiday, the next working day will be taken as crucial last date. The crucial date for determining the age limit shall be the closing date for receipt of application from the candidates.
- Maximum Age limit for the post of Scientist/ Subject Matter Specialist (Animal Sciences/ Fisheries): Should not exceed 35 years as on closing date of application.
- Age relaxation to SC/ST/OBC/PH candidates is as per Government of India rules.
