- (i) The reduction will be w.e.f 2017-18. The students admitted into the 2 units in course in 2017-18. 2016 - 17 will however be entitled to continue with and complete their 2nd year
- (ii) Admissions in 2017-18 will be limited to one unit of 50. The affiliating Universities will please ensure that this is strictly observed.
- (iii) Notwithstanding the restriction of admission in the first year course to 50 course. The affiliating Universities will please ensure that this is strictly the 2014 Regulations because of the continuing workload in the 2nd there will be no reduction in the faculty strength of 1+15, as prescribed in
- (iv) The faculty strength can be reduced to 1+9 w.c.f.2018-19.
