ORDER

WHEREAS, JSS Institute of Education, Suttur-571129, Nanjangud Taluk, Mysore District, Karnataka was granted recognition for conducting B.Ed course, vide this office order No.F.SRON/CTE/B.Ed/2004-2005/8679 dated 25.11.2004 for an intake of 100 students;

AND WHEREAS, on the basis of the affidavit submitted by them on 28.01.2015, a Revised Provisional Recognition Order was issued vide order No.F.SRON/CTE/A/PS02035/B.Ed/KA/2015-16/64977, dated 16.05.2015.

AND WHEREAS, the above said institution submitted an application on 16.05.2017 requesting therein for reduction of strength from 2 units in its B.Ed course.

AND WHEREAS, request of the above said institution was placed before the SRC in its 342nd meeting held on 05th - 06th July, 2017 and the Committee decided the matter as provided below:

- “ 2.1. The request for reduction of intake strength from B.Ed 2 units to 1 unit is accepted because of the reported urgency relating to proximity of counselling issue an order.
- 2.2. But, this decision is subject to further verification of all documents subsequently for issue of a new IR under the 2014 Regulations.
3. The decision is also subject to the following conditions:
 - (i) The reduction will be w.e.f.2017-18. The students admitted into the 2 units in 2016 - 17 will however be entitled to continue with and complete their 2nd year course in 2017-18.
 - (ii) Admissions in 2017 - 18 will be limited to one unit of 50. The affiliating Universities will please ensure that this is strictly observed.
 - (iii) Notwithstanding the restriction of admission in the first year course to 50, there will be no reduction in the faculty strength of I+15, as prescribed in the 2014 Regulations because of the continuing workload in the 2nd year course. The affiliating Universities will please ensure that this is strictly observed.
 - (iv) The faculty strength can be reduced to 1+9 w.e.f.2018-19.

4. This arrangement will come into force with immediate effect because of the urgency of admissions relating to proximity of counselling. But, it will be subject to subsequent production of the under listed documents by the institutions concerned.

- (i) Resolution of the sponsoring society,
- (ii) NOC of the Affiliating University,
- (iii) No Dues Certificate relating to the Teaching faculty,
- (iv) No Dues Certificate relating to the non-Teaching Faculty.”

NOW THEREFORE, the request of the above said institution for reduction of intake from 2 units to 1 unit in the B.Ed course is permitted herewith subject to the conditions indicated in the above para and fulfilment of the conditions mentioned vide order F.SRON/CTE/A/PS02035/B.Ed/KA/2015-16/64977 dated 16.05.2015.
