**Sri Anoop Natwar Mehta**, CPA, CGMA, is the Association of International Certified Professional Accountants Chairperson. He has served in several voluntary organizations, such as the AICPA Board of Directors, the Association of International Certified Professional Accountants Board of Directors, the AICPA Business and Industry Executive Committee, the AICPA Political Action Committee and the AICPA Council.

Sri Mehta is currently the Chief Strategist for Analytical Mechanics Associates, Inc. (AMA). He provides expertise in critical areas of business development, strategic planning, and operational improvements across AMA. AMA has worked with government and commercial organizations solving the most challenging engineering, science and business problems. After stepping down as the President of Science Systems and Applications, Inc. (SSAI) in 2021, he led the executive management team and was instrumental in the company's overall development. He was responsible for managing, planning, and implementing the company's strategic goals. With more than 40 years of experience in government contracting, he actively supported NASA and NOAA programs in an executive management capacity for SSAI. He was in SSAI in 1980 and helped the company to grow from a two-person entity to more than 1,000 organizations. The company achieved profit above the target level every year during his tenure.

Sri Mehta was the Chairperson (2012-13) of the Maryland Association of Certified Public Accountants (MACPA). He has served on the Government Contractors Committee for the MACPA and chaired it for two years (2001-03). He is a former Board Member and Past President of the Maryland Space Business Roundtable. He holds a seventh-degree Master Black Belt in Tae Kwon Do and has been teaching martial arts and operating a Karate School for the past 35 years. A B.Sc. graduate in Accounting from the University of Maryland. He also serves on the Board of Advisors of Robert H. Smith School of Business and the Accounting and Information Assurance Department (Maryland University's affiliate).
